- Not for commercial use. For residential use only.



- Furniture may scratch floors. We recommend using furniture pads to protect your floors.



- Do not put hot items directly on furniture surface.



- Do not clean furniture with harsh cleansers or polish.



- Do not place furniture under direct sunlight.



- Do not place furniture near heating or cooling vents.



- Do not write on furniture without a padded barrier to protect the surface.



- Do not place furniture outside . For indoor use only.



- Stains may be removed with mild soap solution and damp cloth.



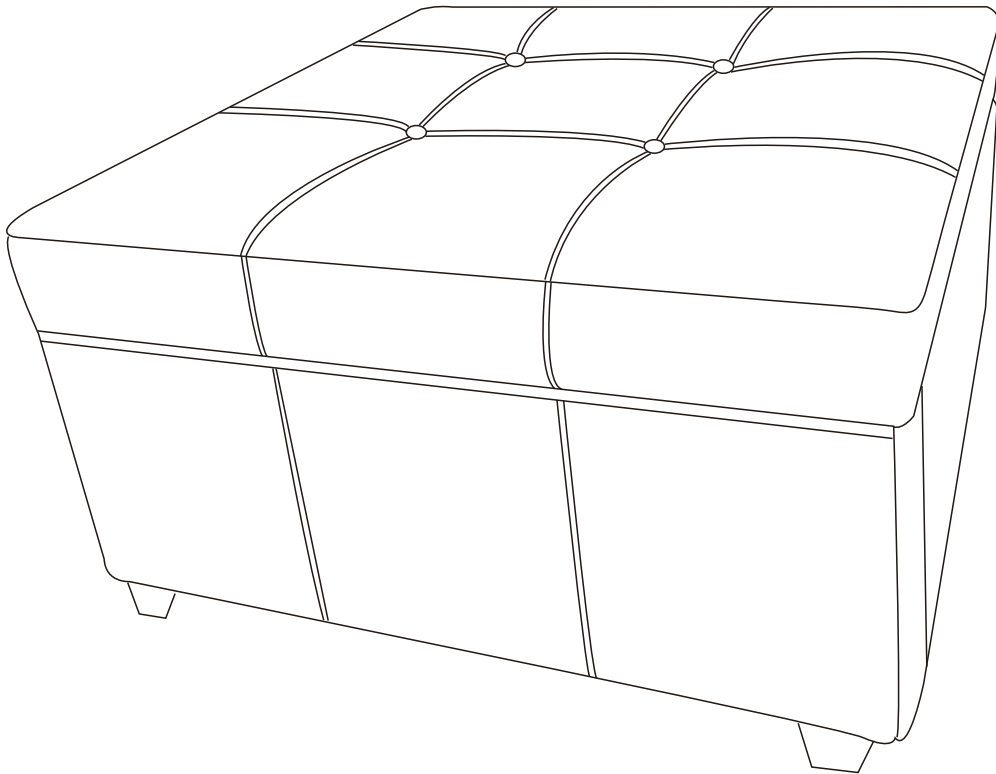
- Children should not climb or jump on the furniture.



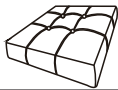
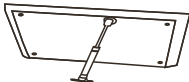
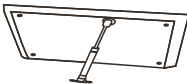
- Dust and pick-up spills using a clean, non-colored, lint-free cloth.

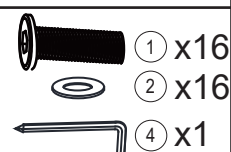
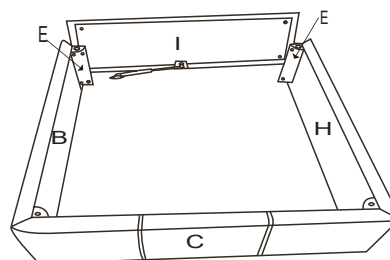
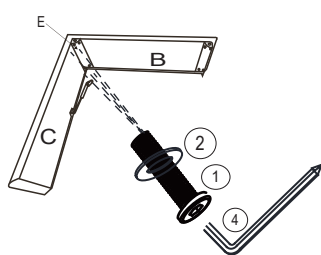
Assembly Steps

Overview



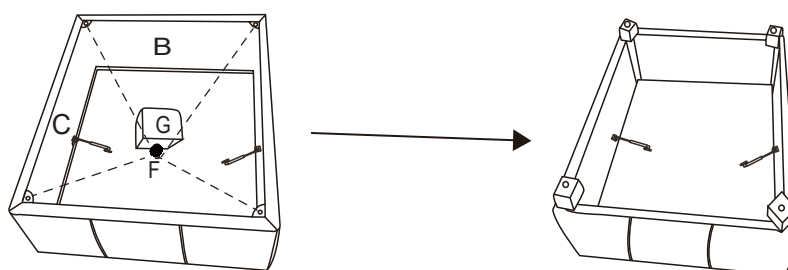
This ottoman has multiple parts and may require up to 10 minutes to assemble. To give you an overview of the ottoman parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.

Step 1



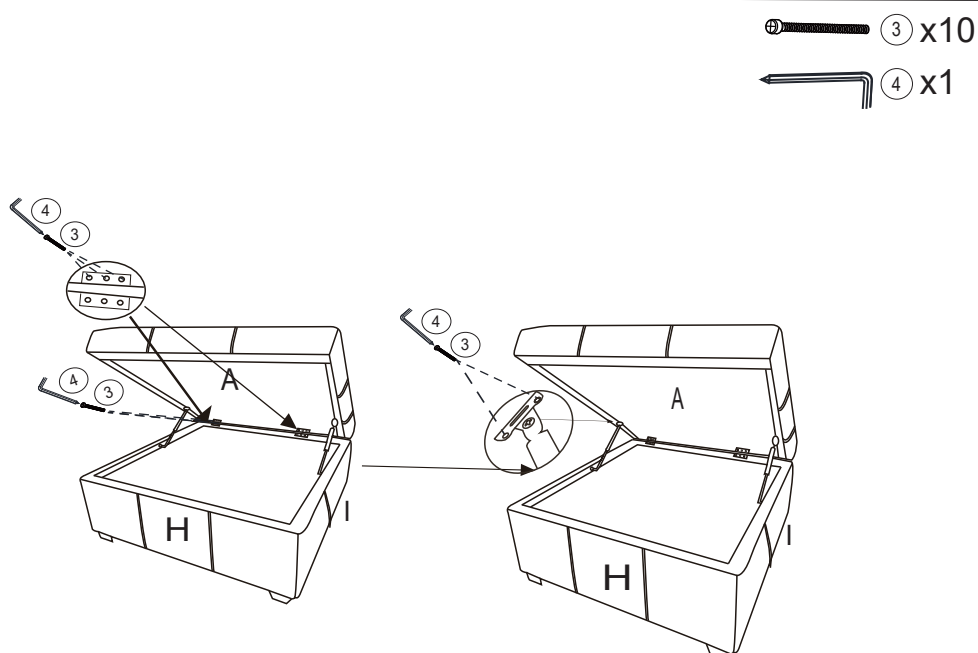
Place the later long ottoman (B) with hinges and the left short ottoman (C) upside down on a clean surface. Align the bottom of the angle iron(E) with the holes on the long chair leg with the hinge and the short chair leg with the gas cylinder close to the long one. Install the screws (①) and flat washers (②), then tighten them using an Allen wrench (④).

Step 2



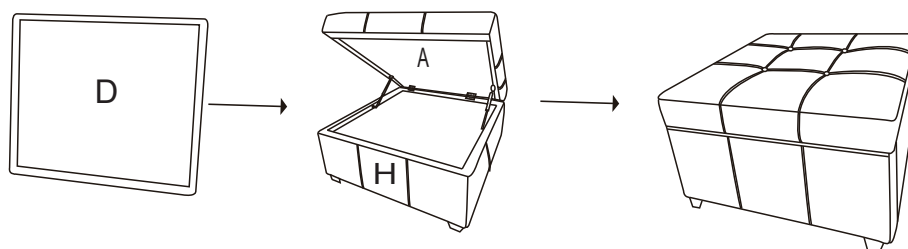
Turn the first assembled part upside down on a clean surface. Align the stool legs(G) with the holes in the angle iron(E), then tighten them.

Step 3



According to the diagram, align the ottoman top(A) at a 45-degree angle with the front long ottoman(H) top, and secure it with small bolt(3). Then align the gas lift rod of the right short ottoman(I) top with the holes in the ottoman body at a 45-degree angle, and secure it with self-tapping screws.

Finished



According to the diagram, insert the lower plate (D) into the ottoman at a 45-degree angle as shown, and your ottoman will be ready to use.

This ottoman can only be used on a flat and level surface.

Questions & Answers about Proposition 65

• What is Proposition 65?

Proposition 65 requires businesses to provide warnings to Californians about significant exposures to chemicals that cause cancer, birth defects or other reproductive harm. These chemicals can be in the products that Californians purchase, in their homes or workplaces, or that are released into the environment. By requiring that this information be provided, Proposition 65 enables Californians to make informed decisions about their exposures to these chemicals. Proposition 65 also prohibits California businesses from knowingly discharging significant amounts of listed chemicals into sources of drinking water. Proposition 65 requires California to publish a list of chemicals known to cause cancer, birth defects or other reproductive harm. This list, which must be updated at least once a year, has grown to include approximately 900 chemicals since it was first published in 1987.

• What types of chemicals are on the Proposition 65 list?

The list contains a wide range of naturally occurring and synthetic chemicals that include additives or ingredients in pesticides, common household products, food, drugs, dyes, or solvents. Listed chemicals may also be used in manufacturing and construction, or they may be byproducts of chemical processes, such as motor vehicle exhaust.

• What does a warning mean?

If a warning is placed on a product label or posted or distributed at a workplace, a business, or in rental housing, the business issuing the warning is aware or believes that it is exposing individuals to one or more listed chemicals. By law, a warning must be given for listed chemicals unless the exposure is low enough to pose no significant risk of cancer or is significantly below levels observed to cause birth defects or other reproductive harm.
