
### Assembly Steps

### <u>Overview</u>



This Sofa has multiple parts and may require up to 30 minutes to assemble. To give you an overview of the Sofa parts, the above picture is to help you put the various parts into perspective. Please read through the instructions below to familiarise yourself with the parts and steps before assembly.


### Step 1



Open up the carton and place all parts onto a clean, non-marring surface.

- 1.1Then open up the Seat(B).
- 1.2Remove the Backrest(A),Legs(C) and hardware.

### Step 2




With the seat(B) open, align Backrest(A) and the open Seat(B) as shown in the picture.

2.1Attach middle mounting position of Seat(B) and Backrest(A) using Bolts(1), Spring Washers(2), and Washers(3) with Allen Key(4). **Do not fully tighten the Bolts.** 

Repeat the same process to attach the remain mounting position.

- 2.2After 6 bolts aligned, tighten all Bolts(1) with Allen Key(4) fully in a sequential manner.
- 2.3Then close the seat(B) as shown in the picture.

### Step 3




Install Leg(C) to Seat(B) by first placing a Gasket(⑤) onto the threaded stem of the Leg(C).

Then insert the Leg(C) into the corner of the base of the Seat(B). Tighten by turning Leg(C) clockwise by hand.

Repeat the same process to install the remaining three Legs(C).

Note: The use of Gaskets is optional. They are especially useful for alleviating slight wobbles from the Sofa. Some Legs may require more than one Gasket whilst some Legs may not require any.






Stand the Sofa up.

#### Care & Maintenance



Do not clean furniture with harsh cleansers or polish.

Do not place furniture under direct sunlight.

Do not place furniture near heating or cooling vents.

Do not write on furniture without a padded barrier to protect the surface.

#### What is Proposition 65?

#### Why Did I Find a Proposition 65 Warning on My Home Goods Product?

We include Proposition 65 warnings on all of our products because there is always a chance that one of the 800-plus common chemicals and ingredients listed under this law could potentially be on our furniture or packing materials. We risk large fines under this law, if we don't include this warning.

#### Should I worry?

We realize you may be worried finding this warning on our products, but we want to reassure you that the hazardous exposure limits for any of these chemicals have never been found on furniture products that we've shipped to our customers. Additionally, this warning label is very common and can be found on almost every piece of furniture sold in the state of California.

Proposition 65 warnings have become so common in California that it is hard to take a trip to a local bank, grocery store, or restaurant without finding at least one warning. In fact, even the Disney Land Resort has a Proposition 65 warning:
